Instant Tennis is a program geared toward our newest players who have never played tennis before. Courtside will provide you with a loaner racquet, an energetic and enthusiastic professional, and an opportunity to learn tennis in a fun environment.

Instant Tennis is comprised of six 90-minute classes, and will be held on Saturday mornings from 7–8:30 am. Each class will be broken up into a 75-minute on-court session with a 15-minute off-court “classroom” session for discussion and review.

The program will use the most innovative and enjoyable ways to learn tennis, such as QuickStart tennis and low-compression balls. Groups are comprised of adults who have never played before so everyone is in the same “boat” and can learn together.

Courtside will provide the racquets and balls to learn tennis!

Players who attend Instant Tennis should come prepared with tennis or athletic clothing (T-shirt and shorts) and sneakers.
